Commissioners & Department Reports

Utilities:

Mayor Reasoner gave the utility report.

Alderman Johnson reported Matt has been working to program all gas meters electronically within the ITRON system and this month he was able to scan all meters with the exception of those without an ERT head.

Matt Dill stated the gas department has about 60 old meters without ERT heads, many are in the business district.

Finance:

Vice Mayor Johnson would like to schedule two workshops in May. Vice Mayor Johnson stated he would like to discuss the budget and get the budget narrowed down. He stated hopefully by the end of May things will be closer to normal and data that we receive from the state and TML will be more exact on revenue sharing. We will also be applying for some grants that could help to offset a portion of that revenue.

Park:

Alderman Johnson reported the house is virtually finished. There are two or three odds jobs to be completed by the contractor.

Alderman Johnson stated he was going to get someone to look at the pavilion at Bobby Robb Park. The pavilion is leaning.

Alderman Johnson stated he is going to speak with park board about reducing the size of the playground at Bobby Robb Park. The mulch and timbers estimated were around \$13,000. He stated the playground is a huge area and a lot of the area is empty. He stated the merry-go-round probably should be removed due maintenance and repair issues. He stated we would retain the merry-go-round for historical sake. It was possibly the first piece of playground equipment the city ever purchased.

Streets:

Mayor Reasoner stated they are looking at streets that need to be paved.

Fire:

Alderman Deweese gave the fire report. All fire department training is suspended due to COVID-19.

Alderman Deweese reported the American Red Cross blood drive was today at the fire hall. Mayor Reasoner stated there was a good turnout.

Pat Hickey Gas Inspection Update

Pat Hickey reported over the last month and a half he has been pretty busy. Mr. Hickey reported he has updated the Operations & Maintenance plan updated. This was reviewed as part of the inspection and signed off on along with the Emergency Operations Manual. He stated as previously reported after the review of our system there was some issues. We have been through a pretty detailed inspection of valves, pressure testing, excess flow valves, operator qualification protocol. He stated for the most part there were no surprises. There were three violations. The first, not adequately documenting pressure testing of service lines, there has been a plan of action established and he believed it was very liberal from the state's standpoint. The initial discussion would be to go out and excavate each service and pressure test it, but the state has agreed to allow us to bump up the pressure to a higher pressure and do a leak survey of those service lines and we will be good. He believes that will work out very well. The second, failure to maintain critical valves. Matt Dill attested to him and Dan Seeback had done all of the non-critical valves and someone else was taking care of the critical valves. However, there is no documentation of the work being done. The correction for this is they will go ahead and complete the critical valve maintenance. This will take a day to day and a half and will clear this violation. The third, excess flow valves, these valves are required on all new service installations and designed if they service line is hit by a contractor or someone and there is a sudden flow through this valve, and it will automatically shut. Since 2012 they have been required on all new installations. There are

inadequate records of those being installed. One option is to dig these services up and verify they are there. With Matt's assistance in knowing they have been installed in certain instances and some review of other records such as inventory records they are going to allow us to sample 21% of the service line where there is no record. This is to basically take the service connection loose, open the valve and let the gas blow out and the valve should shut off. Upon completion, document and submit report to state and that will close that violation.

Pat Hickey stated the state was very happy with the direction things are going. He reported they looked at some of the work and record keeping that Matt Dill is doing and was very satisfied with this.

Pat Hickey stated he believed Mayor Reasoner had an opportunity to talk with the Assistant Director of TPUC today and from their viewpoint Ridgetop was all square with the Tennessee Public Utility Commission.
